Section 1: Understanding and Acceptance of Policies

- A staff member has reviewed the daycare policies with me, and explained where on the website to find more information.
- I understand that the policies may change. If they do, I will be sent the new Handbook via email and will have one month to consent to the changes.

Section 2: Membership and Billing

- In order to activate my membership, I agree to have my credit card billed as follows, now and/or on the 25th of the month, for the next month's membership:
 - Occasional: \$10/mo., for \$20/hour rate – flexible use, no min. purchase
 - Regular: \$60/mo., for \$15/hour rate – cheaper option after 10 hours/mo.

- To switch or cancel my membership, I will submit the [Switch/Exit Form](#) before the 15th of my switch/exit month. Upon cancellation, I will return my door cards and hereby give Buddings permission to withdraw funds owed on any outstanding invoices prior to closing the account.

Unused hours are subject to a 2-hour roll-over deduction, and are made available to active members on the 1st of the new month. This is waived for missed visits due to illness. Buddings does not provide refunds for unused hours.

Section 3: Accounts and Communication

I understand that the “Allergies” field online can be used to communicate any information relating to health and care. I will keep my account information up to date, and will communicate any care requirements to centre staff.
